

Conditions of participation

§1 Promotion

The organiser of this sell-out promotion is DELTICOM AG, Brühlstraße 11, 30169 Hannover (hereinafter referred to as “the operator”). Participation in the promotion takes place exclusively under the conditions listed here. By participating in the promotion, the user accepts these conditions of participation.

§2 Winnings/Prize

The prize is a petrol voucher (to the value of 650 GBP). This voucher will be paid by Delticom AG as a cash payment or bank transfer to the winner’s provided account.

§3 Conditions of participation in the promotion

In order to participate in the promotion, the participant must purchase at least 2 summer, winter or all-weather tyres of the Goodyear and Dunlop brands at <https://www.mytyres.co.uk> during the promotion period, and have provided his complete name and contact details (email address and telephone number) in the specified order form and have placed a tick in the box “participate in the competition”.

The promotion will run during the period between 01.10.2017 (00:00) and 19.12.2017 (24:00) on <https://www.mytyres.co.uk>. The person eligible to participate is the person in whose name the email address is registered. The participant is responsible for the correctness of the provided address. Participation in the promotion is free of charge. The minimum age for participation is 18 years, and participation is limited to natural persons, provided they are not legally incompetent. Replacement is not possible. Disbursement in parts is not possible. Entitlement is not transferable/assignable.

The participants will receive the possible winnings by cash payment or bank transfer. The participants’ personal information will be collected and processed only during the running of the promotion, and will be deleted after the conclusion of the promotion.

By providing the aforementioned information to Delticom for the purpose of participating in the competition, the participant consents to the collection, processing and use of this information to the aforementioned extent.

He can also withdraw the above consent at any time with a written statement to datenschutz@delti.com, request disclosure of the information saved about him and/or its deletion, provided that Delticom AG is not constrained by legal requirements to continue to keep the information available.

§5 Data protection regulations, indemnity declaration

Furthermore, with respect to the collected information, participants have the right guaranteed by the Federal Data Protection Act to disclosure, correction and deletion. §6 Disqualification from competition
