

Terms and Conditions of the Contest

§ 1 Promotion / Draw Delticom AG, Brühlstraße 11, 30169 Hannover, Germany (hereinafter also referred to as "Delticom") is organizing the contest. Michelin Reifenwerke AG & Co. KGaA acts as the sponsor of the prizes. Participation in the promotion is exclusively under the conditions listed here.

§ 2 Prize / Reward As part of the contest, a Go Pro HERO 12 + Max Lens Mod 2.0, a DJI Mini 2 SE Fly More Combo drone or a JBL Charge Essential 2 Bluetooth speaker will be raffled after the purchase of 4 Michelin tires.

§ 3 Conditions for Participation in the Contest By participating in the draw, the user accepts these terms and conditions. Participation in the draw is voluntary and free of charge. Participation in the draw is only possible in one's own name; participation for third parties is not allowed. The minimum age for participation is 18 years and participation is limited to natural persons, provided they are not incapacitated. A cash payout of the prize or an exchange is excluded, even in parts. The claim is not transferable/assignable.

§ 4 Execution and Handling The participation period is from 01.09.2024 at 0:00 AM to 30.09.2024 at 11:59 PM. To participate in the contest, the participant must purchase 4 Michelin tires at Mytyres.co.uk, enter their full name and the requested contact details in the participation form on the order confirmation page, and check the box "Participate in the promotion". The person whose name is registered for the email address is considered eligible to participate. The winner will be determined by a random computer draw after the contest ends. Participants' personal data will only be collected and processed for the execution of the action and deleted after the action is processed. The delivery of the prize will take place after the promotional period. Delticom reserves the right to change, cancel, or terminate the draw at any time without prior notice and without stating reasons. If proper execution of the draw cannot be guaranteed for technical reasons (e.g., viruses in the computer system, manipulation, or errors in hardware and/or software) or for legal reasons, Delticom reserves the right to terminate it immediately. A participant's behavior can lead to the immediate termination of the draw, especially retroactively and/or if there is an obvious lack of intention to participate, for example, if they are a member of a so-called voting group; click community, etc. and use this support during participation and thus gain an advantage. In this case, Delticom can exclude individual participants (even retroactively). In cases of retroactive exclusion, the prize will be raffled again among all participants. Changes to the terms and conditions and the termination of the draw will be announced by Delticom on the participating internet presentation

and by email.

§ 5 Data Protection, Legal Basis for Data Processing, Privacy Policy Delticom AG is responsible for data protection within the meaning of Art. 4 No. 7 of the EU General Data Protection Regulation (GDPR). The legal basis for all the data processing mentioned is Art. 6 (1) (b) GDPR ("contract performance"). We process personal data for the purposes of contest registration, execution, and processing. We collect and store survey responses for marketing purposes (e.g., to create advertising slogans or to plan marketing campaigns). During the storage period of participant responses, assigning the responses to the respective participants is technically possible but not intended. We draw general conclusions from the responses. All personal data is stored in accordance with statutory limitation periods for three years from the beginning of the following year (storage criterion). The legality of storage follows from Art. 6 (1) (c) GDPR if we have to comply with statutory archiving obligations and Art. 6 (1) (f) GDPR ("legitimate interest"). It is our legitimate interest to store the data for legal defense purposes until the expiry of possible claims from participants arising from the contest. Data processing is limited to proof purposes. You have data protection rights (so-called data subject rights), particularly a right to object to the aforementioned data processing and a right to information. The operator is also not liable for damage to participants' hardware or software caused by or resulting from their participation in the action. Delticom is not liable for defects or damage to the prize.
