

## Terms and conditions of the competition

### § 1 Promotion / prize draw

Delticom AG, Brühlstraße 11, 30169 Hanover, Germany (hereinafter also referred to as "Delticom") is organising the competition. Goodyear Operations S.A. acts as the sponsor of the prizes. Participation in the promotion is exclusively subject to the conditions listed here.

### § 2 Winnings / Prize

As part of the competition, 3 Goodyear Fanshop vouchers will be raffled off after the purchase of Goodyear tyres. At least 2 tires must be purchased.

### § 3 Conditions of participation for the raffle

By participating in the raffle, the user accepts these conditions of participation. Participation in the raffle is voluntary and free of charge. Participation in the raffle is only possible in the participant's own name; participation on behalf of third parties is not permitted. The minimum age for participation is 18 years and participation is restricted to natural persons, provided they are not legally incapacitated. A cash payment of the prize or an exchange is excluded, also in parts. The claim is not transferable/assignable.

### § 4 Realisation and processing

The participation period is the start of the raffle from 01.05.2024 at 0.00 am to 31.05.2024 at 11.59 pm.

To take part in the competition, the participant must purchase at least 2 Goodyear tyre from [mytyres.co.uk](https://mytyres.co.uk) and enter his/her full name and the required contact details in the participation form on the order confirmation page and tick the box "Take part in the promotion".

The person in whose name the e-mail address is registered is deemed eligible to take part. The winner will be selected at random by computer the following day after the end of the competition. The personal data of the participants will only be collected and processed for the purpose of organising the competition and transmitted to Goodyear Operations S.A., which may also store the personal data for the duration of the competition, insofar as the storage and transmission is necessary for the execution of the competition, and will be deleted after the end of the competition. The prize will be transferred by Goodyear Operations S.A. after the end of the promotion period. Delticom reserves the right to change, cancel or terminate the competition at any time without prior notice and without giving reasons. If for technical reasons (e.g. viruses in the computer system, manipulation or errors in the hardware and/or software) or for legal reasons it is not possible to guarantee the proper execution of the competition, Delticom reserves the right to terminate the

competition immediately. The behaviour of a participant can lead to an immediate termination of the competition, especially retrospectively and/or in the case of an obvious lack of intention to participate, e.g. if the participant is a member of a so-called voting group, click community or similar and uses this to support and gain an advantage when participating. If this is the case, Delticom can exclude individual participants (also retrospectively). In the event of a subsequent exclusion, the prize will be raffled again among all participants. Changes to the conditions of participation and the cancellation of the competition will be announced by Delticom on the participating website and by email.

#### § 5 Data protection, legal basis for data processing, data protection regulations

Delticom AG is the data protection responsible party within the meaning of Article 4 No. 7 of the EU General Data Protection Regulation (GDPR). The legal basis for all of the aforementioned data processing is Art. 6 para. 1

b) GDPR ("Contract fulfilment"). We process the personal data for the purposes of the competition registration, implementation and processing. We collect and store the survey responses for marketing purposes (e.g. for the creation of advertising slogans or the planning of marketing campaigns). During the storage period of the participant responses, an allocation of the responses to the respective participants is technically possible, but not intended. We draw general conclusions from the responses. All personal data is stored in accordance with the statutory limitation periods for three years from the beginning of the following year ("Storage criterion"). The permissibility of storage results from Art. 6 para. 1

c) GDPR, if we have to comply with legal archiving obligations and Art. 6 para. 1

f) GDPR ("Legitimate Interest"). It is our legitimate interest to store the data for the purpose of legal defence until the expiry of limitations for possible claims of the participants arising from the competition. The data processing is limited to verification purposes. You are entitled to rights under data protection law (so-called Data Subject Rights), in particular the right to object to the aforementioned data processing and the right to information. Furthermore, the operator is not liable for damage to the participant's hardware or software caused by or resulting from participation in the promotion. Delticom is not liable for defects or damage to the prize.

#### § 7 Exclusion from the competition

Employees of Delticom and its affiliated companies are not eligible to participate. Legal recourse is excluded. Participation in the competition is exclusively subject to the conditions listed here
